## Speaking Where The Bible Speaks; Silent Where The Bible Is Silent

July 27, 2014



You are welcome to another edition of our Cameroon missions report from Limbe. I am very happy to share with every one of you the current news of our work in the mission field of gospel preaching in Cameroon. I am blessed to remind you that Cameroon missions is climbing to higher grounds in the field of evangelism and church edification. A review of the happenings

in the month of June will attempt to answer some of the questions that you may have regarding the current state of affairs in the restoration campaign that Apostle Paul and Alexander Campbell and others of similar persuasion have left for us. We gratefully did what we could to continue with the preaching of the word which has resulted in the saving of many lives.



First, let's tackle your question of evangelism. In June we did our best to evangelize our people. Some of them renounced their stubborn will in submission to Christ through the power of

the good news. Yes, we sweated and jugged around in June with the message of salvation. We distributed a number of tracts as we presented the unchanging gospel. I had been evangelizing one reasonable young man by the name of Awah. He was one of those who gave us attention his attention. I personally immersed him at the pool of water close to our church building while brother Richard Niba took the pictures as an eyewitness of the event.

The way we do evangelism in Limbe makes it effective. We commit the faithful gospel to faithful people who are enthusiastic about soul-winning. On such young men I have groomed in the preaching of the word is brother Guy Mbappe, a strong member of the Washing Point Church of Christ. Through his efforts, we now have three newly baptized believers ( a father and his two daughters). It is interesting to note that prior to their baptism by Guy, brother Pascal and his two daughters Muslims. Brother Pascal himself is also a marine officer in the Cameroon Navy. They are now Christians and members of the Church of Christ. These new brethren need a special new convert's class to teach them the Bible so they could start growing in their knowledge of God and Father of our Lord Jesus Christ who is very different from Allah. I will be grateful to receive strength from your collective prayers for God to see me though this exceptional task of mentoring former Islamic adherents into soul-winners for Jesus. With God all allocated duties can be accomplished. I have included the pictures of the two young sisters ( former Muslim girls) while in Church during the last Wednesday Bible class.



That was not all the news about evangelism in June. I thought you would like to hear about my missionary journey to Buea, the capital of the South west Region of Cameroon where the lone Anglophone University in Cameroon is situated. The Buea Town church of Christ organized a four-day gospel lectureship and gave me the evangelistic parable of the great banquet to speak on. At the end of the event some souls were brought to Christ. Glory be to God.

Back in Limbe, our radio preaching is perhaps the greatest obstacle to the spread of denominational gospel. We have two slots on Eden Radio and one on Eternity Gospel Radio. Each air time gives us two hours to tell them about the gospel truth. We hope be on television some day to preach and demonstrate how to be baptized and then worship as a New Testament believer. We will get there God willing.

Now concerning the Church at Washing Point, we are working hard to move the congregation forward in all aspects of our God-given duties to one another and to the world. The only militating factor in our campaign for Christ and church growth is the former preacher of New Town Church of Christ who

seems to have sworn an irrevocable oath to destroy the work we are trying to do in Limbe for the gospel. Sakwe Isaac is still has once again made a move to sue the New Town church to court, alleging that the church plot at a location called Mukunda is his land. The lawyer ha has hired happens to be the proprietor of Eternity Gospel radio with whom I have to do, because I preach on that radio every Saturday 3.00 in the afternoon. Last Saturday about 12 noon, the barrister called me on phone to seek my advice concerning the litigation Sakwe is instigating against the New Town church The Lawyer had to call me because I I belong the group he calls partners to the ETERNITY GOSPEL RADIO. And moreover, when Sakwe narrated his false stories to the legal practitioner, he made mention of Abasiama is one of those came and strengthen what he (Sakwe) calls the “break away from his church”. Sakwe sees me as an enemy in Limbe. So you can see how Sakwe has blackmailed the church in Limbe and Cameroon in general in front of a lawyer (who is also a Pentecostal pastor) that I have become socially friendly with ever since I started preaching on his radio. The lawyer told me that Sakwe was seeking an injunction ordering the New Town church to discontinue all church activities in their congregation until the ownership of the Mukunda land is settled in court. Ever since the Kingston Church stopped supporting Sakwe, he has acted like a wounded lion, confiscating church assets and fighting to exterminate the congregations in Limbe. Brethren, what shall we do? This is one of the setbacks we are faced with. It is problem we cannot ignore because it is an effective sabotage against our evangelistic efforts. Could this be the gates of Hades trying to prevail against the church? We need your prayers.

I know you have been praying for us. It is very easy to be a preacher in Cameroon, Let me not say Africa, as a whole. Often times it is a nightmare. Bad people are everywhere with a lot of malice and hatred, specializing in mischief cruelty against the church. That is why we always look for any opportunity to express our gratitude to those men and women of goodwill who have gone beyond just well wishes to actually commit their financial resources to the sponsorship of the preaching work in Cameroon. We thank you and thank you again. You are co-builders with Christ. With your help, a big difference has been made already. Souls that could have perished in hell are now on their way to spend eternity with God. That is no small difference. It is more than an achievement. It is eternal redemption. Thank you for helping us to be personally committed to the Great Commission. God bless you all.
